You are hereby invited to submit a sealed proposal for the items described below. Quantities and types of oil will vary on a daily basis.

**PREVAILING WAGE**

This is a prevailing wage rate project. The attention of bidders is directed to the special statutory provisions, Ohio Revised Code 4115.02 *et seq.*, governing the prevailing rates to be paid laborers, workers and mechanics employed on public improvements contracts; to Ohio Revised Code 153.59 regarding non-discrimination hiring practices; to Ohio Revised Code 5719.042, requiring a bidder to state under oath whether the bidder has been charged with delinquent personal property taxes; and Ohio Revised Code 3517 *et seq.*, regarding campaign contributions made to the holder of the public office having ultimate authority for the award of a public contract.

**Bidder is required to present as a part of the bid packet the current prevailing wage rate that will be paid to personnel in all classifications employed on this road project per the Ohio Revised Code.**

**Bidder will also be required to verify that all employees used in the work have been paid minimum wage rates established for each classification by the Ohio Department of Labor and comply with Chapter 4115 of the Ohio Revised Code as it applies to Prevailing wage rates.**

**GENERAL BID SPECIFICATIONS**

All contractors shall provide a list of at least three references of work of a similar nature to that being bid so that Baughman Township can judge experience, skill and business standing.

All contractors shall have a State of Ohio Certificate of Qualification from the Department of Transportation accompany each bid.

No bid will be considered unless it is accompanied by a bid guaranty in the form of a bond in the dollar amount of the bid submitted, or, in the alternative, a bidder may submit a bid guaranty in

the form of a certified check, cashier's check or letter of credit in the amount equal to ten percent (10%) of the submitted bid. See Ohio Revised Code 153.08 and 153.54.

If the bid guaranty is a bid bond, such bond shall provide that, if the bid is accepted, the bidder will enter into a proper contract in accordance with the bid and the plans and specifications. The bid bond shall further be conditioned to indemnify the Township against all damage suffered by failure to perform the contract, in accordance with Ohio Revised Code 153.54 and will be in proper, in accordance with Ohio Revised Code 153.57.

If the bid guaranty is a certified check, cashier's check or letter of credit, pursuant to Ohio Revised Code 1305.01 *et seq.*, the bidder will, after the award of the contract, enter into proper contact in accordance with the bid specifications, or become liable to the Township for the difference between its bid and that of the next lowest bidder. See Ohio Revised Code 153.54.

No bidder may withdraw its bid for a period of thirty (30) days after the date of the opening of bids.

**Baughman Township reserves the right to reject any and or all bids and to waive any informality in the bids. Only those bids which are fully executed will be considered.**

Awards will be made to the lowest or best responsible bidder.

The bidder acknowledges time is of the essence in this work. The bidder shall proceed at the direction of the Trustees or their authorized agent.

The successful bidder shall supply flagmen, road signs and barricades as necessary to insure the safety of citizens traveling on the roads of Baughman Township during the performance of this work.

In case of default by the bidder or contractor, Baughman Township may procure the article from other sources and hold the bidder or contractor responsible for any excess cost occasioned thereby, or may cause any performance bond posted to be forfeited.

The bidder shall list on a separate sheet of paper any variations from or exceptions to the conditions and specifications of this bid. This sheet shall be labeled "Exceptions to Bid Conditions and Specifications" and shall be attached to the bid.

Bituminous distributor and aggregate spreaders shall have computerized rate control that automatically adjusts the spread rate to the ground speed.

All materials shall comply with all applicable sections of the current issue of the State of Ohio Department of Transportation construction and Materials Specifications.

Delivery shall be made when ordered by Baughman Township.

Heatable storage of 10,000 gallons must be maintained in close proximity of Baughman Township during the road work to insure proper temperature and speed of work.

**Specifications for 140 lb. bituminous road mix leveling course**

The work shall consist of the careful cleaning of the existing road surface and the construction thereon of a course of aggregate and bituminous material, mixed placed by means of a self-

contained, power propelled, continuous type mixing unit, with a full floating vibratory screed having a minimum depth strike off device of an approved design. Machines without vibratory screed and power extensions **WILL NOT BE PERMITTED**. Compaction equipment shall meet the requirements of Section 401.11 of the Ohio Department of Transportation "Construction and Materials Specifications" latest issue.

**Insurance provision**

It is agreed that the bidder will save and hold harmless Baughman Township, its employees, agents and officials against any liability in connection with the work or service performed by the bidder for Baughman Township.

The bidder agrees to furnish Baughman Township with a certificate of insurance showing proof that the bidder has liability insurance in the amount of \$1,000,000 bodily injury liability and \$500,000 property damage liability, and the bidder also has contractual liability coverage.

**Submission of bid**

All proposals shall be made on invitation to bid forms furnished by the Township, and shall be enclosed in an envelope, sealed and addressed to Baughman Township, and titled, "Chip and Seal."

**Proposal**

To furnish and deliver all materials as specified and to do and perform all work necessary to furnish said materials as ordered.

The undersigned bidder understands that the quantities of materials as shown herein are approximate only and are subject to increase or decrease, and agrees to furnish the material whether the quantities are increased or decreased at the unit prices stated in the bid.
