Baughman Township Trustees met in regular session February 4, 2021 at the Baughman Township office, 3470 N Mt Eaton Road, Burton City, Ohio at 7:00 PM. All members were present. Chairman Calame called the meeting to order and led the Pledge of Allegiance. Geiser made motion to approve the January 7, 2021 regular meeting minutes with the correction to fire report of 130 runs and 140 patients transported. Second Kaufman. Kaufman-yes, Geiser-yes, Calame-yes. Kaufman made motion to approve January 18, 2021 special meeting minutes. Second Calame. Kaufman-yes, Geiser-yes, Calame-yes. Kaufman made motion to pay bills. Second Calame. Geiser-yes, Calame-yes, Kaufman-yes.

Dee Domer talked about the history of the Old Jail dating back to 1852. Dee explained that Old jail is one of the oldest structures in Wayne County and needs to be preserved for future generations. Dee also stated that she is having a difficult time finding pictures and information on the old Jail because of Covid 19. Resident asked about what is going on with Baughman Township and the Mandamus act. Calame stated that is an ongoing legal issue and unable to discuss in depth.

Stoll stated that according to Baughman Township credit card policy, once a year he is to provide the Trustees with annual credit card report for their review. Calame made motion to accept annual credit card report. Second Kaufman. Geiser-yes, Calame-yes, Kaufman-yes.

Calame stated that Stoll needs another printer cartridge. Stoll keeps a spare on hand. Trustees told Stoll to pick one up.

Rehm gave the equipment update: Thanked Kaufman and his father for making a ski for the snowplow on truck one; new tire and rim on truck 2; new tires on f350 ton truck; parts showed up for new holland tractor; doing culvert work on Huprick Rd; tree on Burkhart Rd is starting to split and limb on Rehm Rd need to be taken down, Trustees will talk to Kidron Tree about this issue; Flag in front of office needs to be replaced; Trustees asked Rehm to purchase a new Flag.

Calame stated that the sale of six properties would be left on the table from last meeting.

Geiser stated that the Galion grader is in need of repairs. The cylinder that controls the blade and hoses are leaking. Rehm is to have new seals installed in the cylinder and replace the hoses that are leaking. Rehm stated that the radiator is also leaking. Trustees asked Rehm to remove radiator and get it fixed as well.

Fire Report 2 runs and 3 patients transported.

Geiser made motion to approve financials. Second Kaufman. Kaufman-yes, Geiser-yes, Calame-yes.

Resident asked about Cares Act Funds to Green local schools and EWFD. Calame stated Green Local did not return information needed for the funding grant in time to meet the deadline. Trustees learned EWFD was receiving Cares Act Funding from other entities, decided not to contribute to EWFD.
