## Minutes of Regular Meeting

## May 5, 2022 @7PM

Baughman Township Trustees met in regular session May 5, 2022 at the Baughman Township office, 3470 Mt Eaton Road, Burton City, Ohio at 7:00 PM. All members were present. Chairman Kaufman called the meeting to order and led the Pledge of Allegiance. Geiser made motion to approve the April 7, 2022 regular meeting minutes. Second Graber. Geiser-yes, Kaufman-yes, Graber made motion to approve April 13 Special meeting minutes. Second Geiser. Graber-yes, Kaufman-yes, Geiser-yes. Geiser made motion to pay bills. Second Graber. Geiser-yes, Kaufman-yes, Graber-yes.

Resident comments: Mr. Tom Ballinger Introduced himself to the Baughman residents. Mr. Ballinger is running for Wayne County Sheriff. Mr. Ballinger served in the military and is currently a detective in Copley OH.

Rehm gave Equipment update: Oil change on Ventrac, washed salt spreaders and plows then sprayed fluid film on put away, changed batteries in grader. Burkhart Rd/Misere Rd, Century Link going to purchase the pipe and deliver to shop. Pipe is currently 12 inch and should be 18 inch according to Wayne County Engineer. Trustees stated that the 12 inch pipe was specified by the Township and that this issue should be corrected by the Township. Rehm to purchase 18-inch pipe to correct. State Route 94 and Burton City Rd, visibility issue. This is not Baughman Township road but Rehm did contact Mr. Brock Yoder from Wayne County Engineers office.

Geiser spoke on Tornado Sirens. Received up to date proposal for repairs from B & C Communications, \$8230.60. Trustees need to decide what dispatch they are going to go with 8500 or WarCog. Graber and Kaufman also felt that being able to remotely activate sirens was important. Furthermore, Baughman has been approved by Legal to use ARP money for this project. Geiser made motion to use 8500 as County dispatch and do the upgrades to the sirens communications system. Second Graber. Graber-yes, Kaufman-yes, Geiser-yes. Geiser will research the remotely activation of the sirens.

Geiser stated that by end on May, should have the three sires that are on Ohio Edison switched over to solar. This will save Baughman approximately \$250.00 per month.

Trustees discussed which roads to chip and seal for the 2022 year. Gettysburg Allotment needs to be bermed and chipped and sealed. The Trustees are concerned residents will not want Baughman to do the Berming. This will remove a small portion of resident's yard along the road. Berming is necessary to ensure the water moves off the road and to the appropriate drainage ditch. Stoll will compose a letter that can be given to Gettysburg residents explaining what work is going on and who to contact with questions. Graber stated that Baughman has a lot of roads that need leveled this year. Geiser made motion to chip and seal these roads for 2022: Gettysburg Allotment 1.5-mile, Fox Lake

State Route 57 to Johnson Woods .75-mile, Tannerville south of church Rd 1 mile, and Bodine east of Tannerville .5 mile. Total 3.75 mile. Second Graber. Kaufman-yes, Graber-yes, Geiser-yes.

Kaufman stated that he is waiting on a return call from ODOT on the Trucker Light project. Geiser spoke to Green Township, and they stated that if Orrville Municipal would mount an LED light to an existing pole on the NW corner of the intersection it would cost \$5/mo. This would be shared by Baughman, Milton and Green Townships. If a new pole were to be installed and wired, it would cost \$2,000-3,000. Trustees felt that a solar LED light would alleviate the monthly cost. Geiser is going to look into Solar LED light.

Graber talked on the Shifferly Rd water issue. The culvert by Workinger Farm property is 15 inch and unable to handle the volume of water. Wayne County Engineers office stated that pipe should be 18 inch and a catch basin would help as well. Workinger Farm stated they are willing to pay for the pipe along their property if Baughman Township will install the pipe and catch basin at there cost. Graber made motion to replace culvert pipe on Shfferly Rd from 15 inch to 18 inches. Workinger Farm will pay for the pipe, Baughman Township will do the work of installing the pipe and catch basin at there cost. Second Kaufman. Graber-yes, Kaufman-yes, Geiser-yes.

Graber stated that there is a tree growing in the ditch by Ralph Stoll Farm. Trustees agreed to remove the tree and reshape the ditch.

Kaufman visited with resident at Tannerville Rd about bush on their property creating visibility issues for road. Resident understood but has not been able to remove or trim bush due to health issue. Kaufman offered his help.

Graber was unable to get ahold of the resident on Wayne Street/ Paradise about tree obstructing road visibility. Stopped twice.

Geiser stated that have a camera not working on video surveillance system. Geiser made motion to get camera fixed. Graber second. Kaufman-yes, Graber-yes, Geiser-yes.

Graber stated Sugar Creek is renting a roller this summer. If Baughman is interested in trying one, might be able to rent off Sugar Creek.

Kaufman stated that Baughman might want to consider using ARP money to purchase new snowplow truck. Trustees all agreed that they would not trade the old snowplow truck in, keep it as a third backup.

Resident asked for update on EWFD Contractual lawsuit. Geiser stated no update. Maybe next month.

Fire report 1 Fire, 8 EMS total 9 month of April.

Graber motion to approve financials. Second Geiser. Geiser-yes, Kaufman-yes, Graber-yes.

Geiser motion to adjourn. Second Graber. Motion carried. 8:44PM
