Minutes of Regular Meeting

November 9, 2023 @7PM

Baughman Township Trustees met in regular session November 9, 2023, at the Baughman Township office, 3470 N Mt Eaton Road, Burton City, Ohio at 7:00 PM. All trustees were present. Fiscal Officer Stoll was unable to attend. Chairman Geiser called the meeting to order and led the Pledge of Allegiance. Trustee Kaufman moved to approve November 9,2023 agenda. Second trustee Graber. Graber-yes, Kaufman-yes, Geiser-yes. Kaufman moved to approve the October 5, 2023, regular meeting minutes. Second Graber. Graber-yes, Geiser-yes, Kaufman-yes. Trustee Graber moved to approve minutes from special meeting of October 2, 2023. Second Kaufman. Graber-yes, Kaufman-yes, Geiser-yes. Trustee Graber moved to pay bills. Second Geiser. Graber-yes, Kaufman-yes, Geiser-yes.

The fire report for October was given by NLFD Chief Rock. Seven EMS calls. Chief Rock gave details about two motor vehicle crashes. They are working on dry hydrant flushing in the township. Possibly six dry hydrants remaining that need checked and flushed.

Visitors/Comments: No visitors or comments.

Road supervisor report: Salt has been delivered for this season. All three trucks have been oil sprayed. Cleaned all equipment. New seals installed on garage door between old and new shops. Fixed flashers on New Holland. Heating system required a new tank. Yoder Drilling repaired. New batteries in Case backhoe. Road sign at Fox Lake and Black Diamond was missing. New sign made by Wayne Co. Engineers and replaced. Gutters and downspouts to be installed on salt shed in November. New Kenworth plow truck will be at Henderson this week. Henderson wants to use our truck for display at the OTA Winter Conference. After discussion, trustees agreed to allow the truck to be used for display. Adam to call Wolf Creek Graphics and Troyer Sign about lettering for the Kenworth. Trustees discussed Fallsway and Henderson plows. Motion by Graber to buy the Henderson plow with stainless steel moldboard for \$15,901. Second Kaufman. Kaufman-yes, Graber-yes, Geiser-yes. Adam suggested updating the plow lights on the International trucks. The lights will mount to the existing brackets and do not include a wire harness. Light package for each truck is \$873.46. Motion by Kaufman to purchase light packages for both trucks, second Graber. Kaufman-yes, Graber-yes, Geiser-yes.

Old Business:

EWFD- Graber asked if all documents given to the legal firm will be made available to the township. Geiser said yes. Graber also asked if Geiser will remain legal point-of-contact until the end of the year. Geiser, yes.

Tornado Sirens- B & C Communications is continuing work on the sirens.

Gettysburg Traffic-Graber talked to Brock Yoder at the Wayne Co. Engineers office about speed limit signs. Will do more research on signs. Wayne County does not own radar speed trailers. Cost for new trailers-\$9900. Or they can be rented for \$850/month. A new radar sign that attaches to a post is \$3835. Graber watched traffic in Gettysburg, two shifts in the morning and two in the afternoon. He also noted the county can supply can counters. Orrville city has five radar signs. Gettysburg resident, Chad Schmeltzer, noted that he has observed traffic

between 8am-5pm around 35-45MPH. Some of these are Gettysburg residents. He also mentioned that the city of Fairlawn uses tabletop style speed bumps.

New business:

Baughman Credit Card for Road Supervisor- Road supervisor, Adam Moomaw, passed the probation period in October. Trustees discussed the credit card policy and approving a card. Adam to talk to Fiscal Officer Stoll and get a copy of the credit card policy. Kaufman moved to approve the credit card for Moomaw, second, Graber. Graber-yes, Kaufman-yes, Geiser-yes.

Move Funds Within the General Fund- additional funds are needed for road workers wages in November and December. Funds will be moved within the general fund. The shortfall is a result of the comp time, vacation and sick time payout of the last road supervisor that quit earlier in the year. Motion Kaufman, second, Graber, to move funds. Kaufman-yes, Graber-yes, Geiser-yes.

Motion by Kaufman to approve financial statements. Second, Geiser. Graber-yes, Kaufman-yes, Geiser-yes.

Motion by Kaufman to adjourn 8:14PM. Second Graber. Graber-yes, Kaufman-yes, Geiser-yes.
