Baughman Township Trustees met in regular session October 7, 2021 at the Baughman Township office, 3470 N Mt Eaton Road, Burton City, Ohio at 7:00 PM. All members were present. Chairman Calame called the meeting to order and led the Pledge of Allegiance. Geiser made motion to approve the amended (add wording converting sires to solar) September 9, 2021 regular meeting minutes. Second Kaufman. Kaufman-yes, Geiser-yes, Calame-yes. Kaufman made motion to pay bills. Second Calame. Geiser-yes, Calame-yes, Kaufman-yes.

Visitors comments: Kinsi Kaufman would like to use the Township hall for the Christmas in the Country party on December 3, 2021. Trustees approved. Mr. Andy Stalnacker stated that he just went through a triple bypass on his heart and wanted to let the Trustees know that he is very pleased with the Fire and EMS departments that Baughman Township is working with. Ms. Dee Domer stated that Sherman Mason is the name of person driving too fast on Township roads when responding to Dalton EMS calls. Although residents in audience appreciated his desire to get to the fire station, there is no need to drive at that speed. They are concerned he is going to cause a accident. Mr. Peter Hembree is interested in Baughman Townships properties for sale.

Calame made motion to approve Resolution 2021-8. Baughman Township Trustees will get approval from Wayne County Legal Department, for all disbursements of American Rescue Plan Funds. Second Kaufman. Kaufman-yes, Geiser-yes, Calame-yes.

Rehm Equipment update: Case tractor new temperature switch and expansion valve; Installed cylinder on road grader and washed; Sealed around guard rails at office; Poured floor in culvert on Fox Lake Rd; hauled old concrete culverts to ready mix; mowing ditches; Calame and Rehm looked at a Cat roller, dealer said would give Baughman ODOT pricing; Trustees decided to hold on any purchases of a roller this year and to look into renting roller next year. Rehm would like to get all three trucks undercoated with oil for the winter; Trustees agreed to having this done.

Trustees decide to hold on doing any additional road dragging in 2021, due to costs. Will revisit this issue in spring on 2022.

Geiser stated that Smucker Energy would like to start converting the three sirens on Ohio Edison Electric to solar power in the next two to three weeks.

Calame stated that he is in the process of working with Wayne County Legal and Orrville Fire Department on Cares Act Funds.

Geiser stated that he received a phone call from resident inquiring why bags on fire hydrants. Geiser stated he checked with City of Orrville and they stated that hydrants with bags on them are not pressurized all the time.

Fire report: seven EMS.
