Minutes of Regular Meeting

September 9, 2021 @7PM

Baughman Township Trustees met in regular session September 9, 2021 at the Baughman Township office, 3470 N Mt Eaton Road, Burton City, Ohio at 7:00 PM. All members were present. Chairman Calame called the meeting to order and led the Pledge of Allegiance. Calame made motion to approve the August 5, 2021 regular meeting minutes. Second Kaufman. Kaufman-yes, Geiser-yes, Calame-yes. Geiser made motion to pay bills. Second Kaufman. Geiser-yes, Calame-yes, Kaufman-yes.

Visitors comments: MS. Dee Domer stated that the Baughman buzz is stating that Baughman Township is only owed \$6000.00, when exiting the EWFD and that the Trustees are spending large amounts of the Township's money on Legal fees just to get \$6000.00. Ms. Domer asked if is this true. The Trustees explained that when Baughman Township exited EWFD, Baughman was entitled to 58.2% of funds on hand. This amount is significantly more than \$6000.00. Ms. Domer stated that the Baughman buzz also said that Baughman Township is pocketing the Covid -19 money they received. Trustees explained that Baughman has issued Covid -19 funds to various Fire departments, Schools and non-profit organizations (Library). All funds disbursed to various entities were first approved by Wayne County Prosecutor. Baughman Township was Audited on their Covid-19 funds by Auditor of State, which they passed. Resident stated that they have a neighbor that has junk and trash piled around their home. She has contacted Health Department and Wayne County Sheriff, but they have been unable to help. What can she do to get this cleaned up? Kaufman explained that it could fall under EPA if there is household trash and pollutants getting into the creek. Resident asked if a resident can run for Township Trustee that is delinquent on Taxes. Trustees stated that this would be a question for the Wayne County Election Board. Mr. Andy Stalnacker asked if funds from the American Rescue Plan could be used for new water lines to Baughman Township. Calame stated that Orrville is looking at that project and Baughman would be willing to participated if ARP funds could be used in that manner. Should take a look at dead Oak tree limbs on the six properties that Baughman Township owns.

Kaufman made motion to approve Resolution 2021-7, Accepting American Rescue Plan Funds into Revenue and Appropriations. Second Calame. Kaufman-yes, Geiser-yes, Calame-yes.

Rehm equipment update: Putting seals in Case tractor; Got cylinder back for grader; Pole saw broke, is fixed now. Rehm would like the Trustees to look a roller at Southeastern Equipment. Calame is going to go with Rehm. Baughman Township parking lot is getting cracks in the asphalt, might want to consider resealing. Need a cap for the chimney at the Township Office. Rehm is going to get price on what would cost to put stainless steel cap on. Would like to purchase hard hats for trimming trees. Trustees agree with this but recommended to also get face and ear protection. There are dead trees on Rehm, Black

Diamond, Burkhart and Kohler Rd that need to be taken down. Trustees agreed and told Rehm to get with Kidron Tree Services. Kaufman thanked Rehm and Infield for excellent job of painting office railing and recementing posts.

Kaufman made motion to go into Executive session provisions under ORC 121.22 Sec G: To consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official, or the investigation of charges or complaints against a public employee, official, licensee, or regulated individual. Second Calame. Kaufman-yes, Geiser-yes, Calame-yes. 8:10PM. Out Executive Session 8:24 PM.

Jim Infield is no longer on probation. Calame made motion to move hourly rate to \$20.00/hr. Second Geiser. Kaufman-no, Geiser-yes, Calame-yes.

Kaufman stated that Wayne County Prosecutor has approved Cares Act Funds to be disbursed to NLVFD. Calame made motion that he is working with Orrville Fire Department and once Wayne County Prosecutor approves Cares Act Funds, Stoll is to send out funds. Second Kaufman. Geiser-yes, Kaufman-yes, Calame-yes.

Geiser made motion to accept Baughman Township Workplace Visitor Policy. Second Kaufman. Kaufman-yes, Geiser-yes, Calame-yes. Calame is going to get some signs made up to put outside shop.

Rehm said that a lot of road dragging is needed. Calame tabled this discussion till next meeting.

After discussion the Trustees decided to not participate in OPWC Grant. Instead will focus on using American Rescue Plan funds for projects that are approved by Wayne County Prosecutor.

Geiser stated that Baughman Township should move forward on converting the three sirens to solar on Ohio Edison Electric. Monthly electric cost for these three sirens is \$250-\$280. The solar power sirens would be paid off in two years. Geiser is going to get ahold of Smucker Energy.
